## TITLE IX

As some of you know, I had the privilege of making a presentation at the North American Summit in St. Louis last summer about the assault on Title IX by the current administration. Title IX is the law that allows for equal opportunity in education for males and females in all publicly funded schools. This law has been in place for 31 years. We mostly think of Title IX for girls in terms of sports, but it actually covers any and all activities. Title IX has opened many doors for girls and women.

Although it is not followed to the letter of the law things are much better than they were 31 years ago when the law was passed. When the current administration tried to dismantle Title IX, the hot poker was stuck in the hornets' nest. Such uproar was caused that everyone involved has backed off calling what was going on a "study."

The way I see it now is that our collective job is to watch our local schools. By virtue of what has been going on Title IX is vulnerable and it is up to us to keep watch. If a school is publicly funded, then they must obey the

law. This means that proportionally girls and boys must receive equal opportunity to participate in all activities. We must be the guardians of our girls and young women.

# Service Committee Report

District 12 presents an annual service award at the District Conference. The award consists of the grouping of international flags from countries around the world that have Zonta Clubs. This award is given to the Club that has met the following criteria:

- Annual report turned in by the due date
- High percentage of members are involved in the service project
- Service goals are in line with International service goals
- Community service projects that work to continue improving the status of women within the community
- Projects promote Zonta in the community
- One third of Club service budget is allocated for International service

As always, Zontians of District 12 have given wholeheartedly to your service projects and have been generous to your communities in your commitment to improving the status of women. Zontians have given with time—over 12,520 hours reported—you have given with financial support—over \$201,897 earned in District 12—with \$54,380 reported given to International, and you have given with your hearts. I am pleased to announce that the Zonta Club of Converse County in Douglas, Wyoming was presented this award at the District Conference in Billings. (See the photo above.) Below is a brief description of their projects.



“As with many good ideas, the Zonta Club of Converse County’s Fall Fashion Show, Luncheon & Fundraiser all started from attending District Conference. Irma Cross was president in 2000-2001, and she said other clubs in the District were holding fashion shows as fundraisers and wondered if our Club would be interested. Betty Pexton, who at the time, was also a volunteer for Helping Hands (a subsidiary of 5 churches now called DEMI) had the idea to model donated "slightly used" clothing since we did not have a department store in Douglas to loan us the clothes as you would in a typical fashion show. Used clothing would be gathered from Zontians and friends of Zonta (patrons) and be sold at the show. Women and children could get something new to them for work or play for not more than \$4 and a nominal fee for a terrific lunch! Any items not sold at the show would be given to Helping Hands to then sell in their store. Francie Claus was made the chairperson the first two years and thought the fundraiser chair position to be the perfect method for Zontians to experience the leadership role before becoming club president. Typically chairpersons for the show are chosen from our Zontians of

the Year recipients who have already gone above and beyond in their duties. Mary Jamieson was our Zontain of the Year for 2002-2003 and chair for this year’s show which proved to be bigger and more profitable than ever.

Can you imagine collecting over 1000 articles of clothing or doing the actual cooking for 125? Pat Perrotti met the challenge with the clothing and Kay Moore and her committee were masters in the kitchen. Depending on the recommendation of the fundraising committee, the show might have raffles, bake sales, silent auctions, or tag sales incorporated to help meet varying goals set. Monies have been raised for local scholarships and special projects, Helping Hands, and the Zonta International Service Fund through the fashion show. Lots of energy, creativity, and vision by the Club will keep this recycling fundraiser forever popular within the community.

While the fashion show is one of our newer projects, the Zonta Club of Converse County under the direction of Pat Perrotti has served the community for over 12 years with the Zonta sponsored community blood drive. This drive is held three times a year and collects an estimated 100 pints with each drive. The Zonta Club of Converse County is proud of Pat Perrotti and her dedication to the Club and to this cause. Other service projects have included the Head Start Easter Egg Hunt, womens baskets for the Jubilee House, collecting for the Salvation Army, planting yellow roses at various sites in the community, and painting for Habitat for Humanity.

It is with great pride and appreciation that the Converse County Club accepts the Zonta International Flag Service Award. Thank you District 12!”

## Greetings from Area 4!

### Zonta Club of the Canon City Area

Members of the Canon City Club are busy gathering toiletries before their December 3 meeting to create baskets and bags for delivery to the Rocky Mountain Behavioral Center. These baskets of shampoos, perfumes, and other “grooming” items will be given to women who are leaving the recovery program to help build their self-esteem. This service project first started two years ago after the Center’s director presented a program at one of the Club meetings; it has since been adopted as an ongoing project. Approximately 30 baskets were given at their last donation time, and the Club is looking forward to putting together many more to deliver before Christmas.

### Zonta Club of the Pikes Peak Area

On November 3, a total of 21 people filled Pat Kosley’s house to bag 1,500 pounds of nuts into one-pound plastic bags (all but 100 pounds of the nuts had been pre-sold). Twelve club members, three husbands (fondly called Zontos), three non-members, and one brave young boy took about 1-1/2 hours to get the job done. It seemed the more people talked, the faster they bagged, so in no time mountains of nuts were displayed all over the house. Those members who were present took their nuts with them at the end of the work session and distributed them over the next few days. This project has been a major fundraiser for quite a few years now, but this is the first year the profits should reach approximately \$2,000.

### Zonta Club of Prowers County

Members of the Prowers County Club are gearing up to support the annual holiday home tour, which will be held the first part of December. Sponsored in collaboration with the Daily News newspaper, this tour benefits the domestic violence program in Lamar. Five or six decorated homes are open to the public, tickets are sold to people in the community, and Zontians are stationed at each home to supervise the tour with the homeowner, collect tickets, or to sell tickets to those people just “dropping in.” Club members are hoping enough money can be raised at some point to create a safe home for women in domestic violence situations and their children.

### Zonta Club of Pueblo

At the time of this writing, Pueblo Zontians are planning to hold two ZING (Zonta Informational Network Gathering) meetings on November 12-13 to introduce women in the community to Zonta International. The meetings are being held at a lovely Italian restaurant where seven women will enjoy dinner and a detailed presentation. Governor Mary Benoit, Area Director Kate Brewster, Vice Area Director Jo Ann Russ and Vice President and Membership Chairman Tamara Muhic are on the agenda to talk about the history of the organization, structure, committees, International service projects and programs, local service projects, and membership information. This is an important step to help rebuild their club after several years of declining membership. I’d like to take this opportunity to thank Tamara for her hard work in developing this ZING program and the members for their support. You are to be congratulated on your efforts to enhance and revitalize your club.

# CELEBRATION OF UNITED NATIONS DAY

In 1945 representatives from 50 countries at the United Nations Conference prepared the United Charter for the International organization that was signed on June 26, 1945. The General Assembly of the United Nations ultimately passed a resolution to designate October 24th as United Nations Day and that it be devoted to making known to people the achievements of the United Nations.

Zonta International is among 3,000 not for profit non-governmental organizations who have been given this special designation by the Department of Public Information because they have agreed to have strong informational programs on issues of concern to the United Nations, e.g., health, welfare of women, education, trade, and industrialization. Zonta International has also agreed to disseminate information to its membership and support the mission of the United Nations, through its international service projects in India (promoting the status of women), Afghanistan (health and education for women) and Bosnia-Herzegovina (welfare of women).

Since 1985, Zonta International has had consultative status with ECOSOC (Economic and Social Council)—one of the 6 bodies that carries out the work of the United Nations related to trade, women's rights, children, health and education. Members of Zonta International's United Nations Committee, attend conferences and sessions at United Nations' sites in Geneva, Vienna, Paris and, of course, at the United Nations' headquarters in New York City.

So how did you club celebrate United Nations' Day? Perhaps you had a "UN" moment you shared with your members, invited a guest speaker from a foreign country, sampled some international food, reviewed press releases related to education and health issues affecting women and children in foreign countries, viewed Zonta International President Margit Webjörn's videotape regarding an update of Zonta International's service projects in India, Afghanistan and Bosnia-Herzegovina?

The Zonta Club of Denver II was fortunate to have Meena Desai, originally from an area near New Delhi, India, and currently residing in Denver. Meena spoke about the immigrant Indian woman in the United States and the creation of a local support group in the Denver area to help them adjust to cultural differences. She also shared with us the history of SEWA (Self-Employed Women's Association) registered as a trade union in April 1972. SEWA was born in the labor movement with the idea that self-employed women have a right to their wages, decent working conditions and protective labor laws. The SEWA Bank was created in 1974 to support the labor movement and provide credit to self employed women to sustain their businesses.

As the global economy continues to improve and countries form new alliances all over the world, we only need to be reminded gently that the United Nations has been instrumental in making this world a better place for all mankind.

The two Boulder County Clubs (Zonta Club of Boulder County and Zonta Foothills Club of Boulder County) provided the cake shown at the right at the Boulder UN Day Celebration entitled *Water for the World: A Forum*. There were over 70 people in attendance. The topics included: Water Problems between the US and Mexico; Water, Poverty, and Political Instability in South Asia; and Global Water Quality Issues. Virginia Schultz, International Committee of the Zonta Foothills Club of Boulder County, reports that it was a very informative and worthwhile event.

## Report of the Zonta International Foundation

In 1984 the Zonta International Foundation was established to administer the service programs and projects of Zonta International (ZI). The Foundation is a 501c3 organization, established exclusively for charitable purposes. It receives, raises, and invests the funds donated by Zonta clubs, individual members, and others.

The Foundation Board has seven members, elected for alternating four-year non-renewing terms. It elects its officers for two-year terms.

District 12 is one of the smallest in membership of the 30 districts of Zonta International. For the biennium 2002-2004, through September 30, 2003, total contributions received by the Foundation were \$1,465,000. District 12 has contributed \$59,000+, placing our district 10<sup>th</sup> in giving to date. Included in the \$59,000 is \$5,300 given by 34 individual Zonta members of District 12. Of the clubs represented by these contributions, the Zonta Club of Cheyenne had 8 individual members giving, which is the greatest number of the 22 clubs in the District.

At the District Conference in Billings, the Zonta International Representative, B.J. Bourdon commented on how great it was to visit such a dedicated district. She particularly liked our methods of reporting the dollars given with the percent given to Zonta International and the number of service hours we have donated. It is my pleasure to represent this great District, and I appreciate all of your hard work in the giving of your time and dollars to your communities and to the Zonta World.

As a Zonta member concerned with improving the status of women by helping them to find the power, freedom, and the right to lead better lives, consider a personal contribution to the Zonta International Foundation along with encouraging your club's contributions.
